Class Notes

- Social Security Numbers or Tax ID #'s **REQUIRED** for **OWNER & RIDER** – NO #, NO \$
- Contestants and Owners must be a current NRCHA Member in classes approved by those Associations.
- A copy of horse's registration papers or a vet description of horse's age must accompany entry.

The Open Amateur Bridle \$1500 Class & Junior Horse (\$3500 Non Pro/ \$3500Open) are IntRCHA approved classes. They are not NRCHA approved classes.

- These classes are for Non-Pros who have not won more than \$1500/\$3500 in Reined Cow Horse competition as of 12/31/07.
- Both Classes are intended to be a "stepping" stone for those of you who are just starting out or maybe wanting to move out of the Non-Pro limited (boxing) class. If this describes YOU, please take advantage of these classes.
- NP Limited contestants, remember that you can go down the fence up to 2 times and still go back to the NP Limited class.
- Junior Horse – \$3500 Non Pro/\$3500 Open
 - Your horse must be 5 years old or younger to be shown in either a hackamore or snaffle.
